

INTRODUCTION

The West Penn Power Sustainable Energy Fund (WPPSEF) is a private non-profit Corporation incorporated on May 3, 2000. The creation and funding for the WPPSEF was authorized pursuant to the West Penn Power Company restructuring proceeding approved by the Pennsylvania Public Utilities Commission in an Order dated November 3, 1998.

In 2014, the West Penn Power Sustainable Energy Fund (WPPSEF) entered its fourteenth-year operations. WPPSEF activities continued to increase from previous years as its programs and initiatives become more visible within the West Penn Power (WPP) service region and across the Commonwealth. WPPSEF funding is focused on:

- Promoting the use of renewable and clean energy;
- Promoting energy conservation and energy efficiency; and
- Promoting the start-up, attraction, expansion, and retention of sustainable energy businesses.

HIGHLIGHTS AND ACCOMPLISHMENTS

WPPSEF activities and new funding commitments were very robust in 2014. The WPPSEF Board committed \$1,587,411 to support 17 projects. Implementing these new funding commitments efforts, while monitoring and supporting WPPSEF existing active project portfolio kept the WPPSEF staff and Board very busy throughout 2014. In addition, the WPPSEF started to plan a series of events & activities for the upcoming year in 2015 to celebrate its 15-year anniversary.

2014 Mid-Atlantic Biomass Heat & Power Conference (April 23-24)

WPPSEF is working with the PA Biomass Energy Association (PBEA) to raise awareness on the use of sustainable biomass feedstocks for clean heat and power applications. WPPSEF and PBEA worked to develop, organize, and host a 2014 Mid-Atlantic Biomass Heat and Power Conference. The conference was held on April 23-24, 2014 in Gettysburg, PA. WPPSEF provided a host sponsorship to the conference which enabled

PBEA to secure the meeting space and plan the logistical details of the conference. WPPSEF worked with PBEA to make this a Mid-Atlantic regional event that would attract biomass technologies and businesses to Pennsylvania and to showcase biomass facilities within Pennsylvania. The conference was a mix of panel discussions, technical presentations, and field excursions. The two-day conference attracted over 125 attendees and featured speakers and attendees from across the U.S.. The conference was focused on the use of sustainable biomass feedstocks for clean heat & power applications in the residential, commercial, institutional, and industrial sectors. A biogas field excursions highlighted biogas utilization from a farm-based anaerobic digester (Slate Ridge farm) and the Blue Ridge landfill. A woody biomass field excursion traveled to PA Department of Conservation and Natural Resources (DCNR) Caledonia State Park to learn how DCNR is using wood to heat their facilities and the to Twin Springs Fruit farm to replace coal to heat their greenhouses.

New Showcase Projects

WPPSEF had the opportunity to support several new showcase projects in 2014. These include:

<u>Geisinger Healthcare System (Danville Campus, Montour County).</u> WPPSEF worked with Geisinger to install a nominal 38 kw solar PV system on the Janet Weis Children's Hospital.

Keystone Elk Country Alliance (Benezette, Elk County). WPPSEF worked with KECA to build a 40 x 80 foot LEED-certified Elk Country Campus Outdoors (ECCO) Building. The Elk Country Visitor Center attracted over 350,000 visitors in 2014. ECCO is demonstrating the use of a state-of-the-art Frohling FHG cord wood heating system (Frohling boiler combined with thermal storage in-floor radiant heating system).

Western Pennsylvania School for Deaf (Pittsburgh, Allegheny County). WPPSEF worked with WPSD to support the construction of a new 30,000 ft² LEED Silver residence for deaf and hard-of-hearing children in western Pennsylvania. WPPSEF support was

directed towards the installation of geothermal heat & cooling system, high efficiency lighting fixtures, enhanced insulation, and to defray LEED commissioning costs.

Women-In-Need (Chambersburg, Franklin County). WPPSEF is working with WIN to support the construction of a new construction of a new 11,000 ft² LEED Shelter and Advocacy Center to serve victims of domestic violence and house WIN staff. WPPSEF support is directed towards the installation of a solar thermal system, a variable refrigeration volume (VRV) heating/ cooling system, and a heat recovery ventilator.

Pennsylvania Treasury (Harrisburg, Dauphin County). WPPSEF is working the Pennsylvania Treasury to support an innovative public-private financing program to help non-profit organizations make advanced energy improvements. WPPSEF support is directed to the Foundation for Renewable Energy and Environment (FREE) who is leading the development of an ESCO sustainable energy bond program for energy efficiency projects at municipalities, universities, schools, and hospitals (MUSH) sector. This is an ongoing project.

15-Years of Operations

WPPSEF is planning a series of events and open houses to showcase Pennsylvania's sustainable energy projects & businesses in 2015. Planning started in 2014. Although WPPSEF will celebrate their 15th year of operations in 2015, much the sustainable energy community that is taking root in Pennsylvania started in the late 1990/ early 2000 timeframe. WPPSEF is using this opportunity to celebrate the collective accomplishments of Pennsylvania's sustainable energy community while building additional awareness for renewable energy, smart energy use, and how this can be developed to improve a region's economic development and environmental betterment.

Pennsylvania Sustainable Energy Board (PA-SEB)

WPPSEF provided their annual presentation at the PA-SEB public meeting on January 9, 2014. The meeting was held in the Commonwealth Keystone Building (Hearing Room 1). The presentation reviewed WPPSEF's activities in 2013 and upcoming activities in 2014.

FINANCIAL APPROVALS

The WPPSEF Board committed \$1,587,411 to support 17 projects. A detailed summary of the WPPSEF loan financing and grant making is provided in Tables 1 & 2, respectively.
